- 1. <u>Call to Order</u> Ms. Mullaugh called the meeting to order at 5:35p.m.

- 8.3 Mr. Galloway presented a proposed amendment to the FY 2016 to add in the Accounting Services of Ms. Reed. It did not have a negative impact on the budget due to savings on Adobe Software, Facility improvements postponed until next year, and painting and minor repairs postponed until next year.

A motion was made by David Herman and seconded by Audrey Sanders to approve the proposed budget amendment. Motion passed with all members present voting in the affirmative. The vote was approved unanimously.
